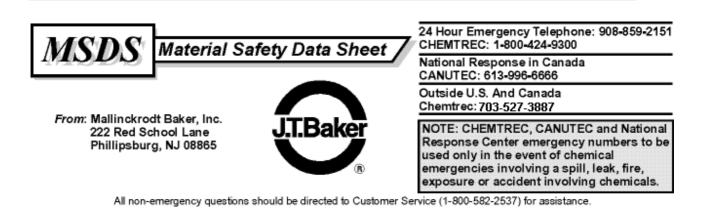

Potential Health Effects
